243-8 Residential, Commercial and Industrial Water Rates.

The water rates to be charged and collected by the Town of Tatum from each residential, commercial and industrial establishment obtaining service from the waterworks systems of the Town shall be as follows: Amended rates shall become effective August 1, 2019.
